**1. Consider Report and Adopt Recommendations of the Interim Rulemaking Subcommittee**

Commissioner Cline provided the report of the interim Rulemaking Subcommittee. Subcommittee members from Oklahoma and Rhode Island provided an initial draft of the proposed operating procedure for resolution of disputes as provided for in Article IV, Section 18 and Article IX of the Compact model legislation. The subcommittee held a public meeting on this proposed rule and is recommending the Management Committee initiate the rulemaking process. Commissioner Cline moved to publish the operating procedure for the resolution of disputes for notice and comment in accordance with the Commission's rulemaking rule. Commissioner Bowler seconded the motion and the motion was adopted.

2. Consider Report and Adopt Recommendations of the Interim Product Standards Subcommittee

Ms. Waitt provided the report of the interim Product Standards Subcommittee. The committee is recommending the Management Committee initiate the rulemaking process for the individual life insurance application standards. The committee has prepared a detailed memorandum outlining the substantive revisions to the draft standards that were prepared by the NAIC's Interstate Compact National Standards Working Group. Ms. Waitt made a motion to publish the individual life insurance application standards for notice and comment in accordance with the Commission's rulemaking rule. Commissioner Bowler seconded the motion and the motion was adopted.

3. Other Business

Ms. Waitt nominated Commissioner Michie to serve as chair of the Audit Committee and Commissioner Cline seconded the nomination. The Management Committee voted unanimously to appoint Commissioner Michie as chair of the Audit Committee.

Ms. Waitt made a motion to modify the deposit account and related services and barring agreement for the Commission to add Jeff Johnston (NAIC) as a signatory. Director Womer Benjamin seconded the motion and the motion was adopted.

Having no further business, the Management Committee adjourned.
