Commissioner Cline called the meeting of the Management Committee to order. Commissioner Cline explained that the first portion of the teleconference was devoted to a Public Hearing on proposed Uniform Standards issued on December 12, 2007, proposed Operating Procedures issued on October 5, 2007 and the proposed Code of Ethics which was issued on January 28, 2008.

Commissioner Cline noted that the Non-Variable Annuity Standard has a pending recommendation memo from the Product Standards Committee to have the non-forfeiture section of this Standards reviewed further by the Product Standards Committee.

Commissioner Cline asked if there were any comments on the remaining Uniform Standards, the Variable Annuity Standards and the Mortality Change Standards. The Industry Advisory Committee provided comments. Miriam Krol, from the ACLI stated that the Committee had provided written comments and there were no other comments. Ms. Krol asked that the comments be considered for approval in the final version of the Variable Annuity Standards. There were no other comments.

Commissioner Cline proceeded to the Operating Procedures which were issued on October 5, 2007. Commissioner Cline asked if there were any comments on the proposed Operating Procedures. There were no comments.

Commissioner Cline proceeded to the proposed Code of Ethics. Commissioner Cline noted that a redlined version was circulated and that it would be best to go through each of the sections and have the interested parties who have submitted comments to explain their comments. (*Attached*

Chris Doane spoke on behalf of Pennsylvania. Don Beatty spoke on behalf of Virginia. Brendan Bridgeland and Rod Bordelon of the Consumer Advisory Committee each provided comments. As each section was detailed, Frances Arricale, IIPRC Executive Director, responded to any questions and further explained the intent of the Code.

Commissioner Cline concluded the Public Hearing portion of the teleconference. Commissioner Cline proceeded to the next item on the Agenda, the consideration of approval of Uniform Standards from the Public Hearing. Commissioner Cline asked the Product Standards Committee to make their recommendation regarding the Non-Variable Annuity Standards. Nick Hoelscher, from Texas, spoke on behalf of the Product Standards Committee as Vice Chair. Mr. Hoelscher recommended that the Annuity Standards be sent back to the Product Standards Committee for further discussion of the concerns that were raised by Alaska regarding the non-forfeiture value prospective test. It was noted that all interested parties, including all the members of the NAIC National Standards Working Group would receive a call notice. Commissioner Cline asked if there was a motion to adopt the recommendation of the Product Standards Committee. Mr. Hoelscher made the motion and Mr. Beatty of Virginia seconded the motion. Commissioner Cline asked Ms. Arricale to take a roll call vote. The motion was approved by a unanimous vote.

Commissioner Cline asked if there was a motion to adopt the Variable Annuity Contract Standards. Director Hudson, from Ohio, made the motion and Fran Wallace, from Michigan, seconded the motion. Commissioner Cline asked Ms. Arricale to take a roll call vote. The motion was approved by a unanimous vote. The Uniform Standards were approved as revised to include the comments submitted by the Industry Advisory Committee.

Commissioner Cline asked if there was a motion to adopt the Mortality Change Standards. Mr. Hoelscher made the motion and Mr. Beatty seconded the motion. Ms. Krol asked if their comments were going to be incorporated in the Mortality Change Standards. Becky McElduff, from the NAIC, replied that the Product Standards Committee did not want to incorporate them. Ms. McElduff noted that the Standards would not be available for use with the so-called "Mix and Match" system. Commissioner Cline asked Ms. Arricale to take a roll call vote. The motion was approved by a unanimous vote.

Commissioner Cline proceeded to the next item on the Agenda, the consideration of approval of the Operating Procedures from the Public Hearing. Commissioner Cline asked Commissioner Thabault to provide a brief report on the two (2) Operating Procedures before the Committee. Commissioner Thabault provided a brief summary of the Operating Procedures. Commissioner Cline asked if there was a motion to approve the Operating Procedures. Mr. Doane made the motion and there was a second.

Commissioner Cline asked Ms. Arricale to take a roll call vote. The motion was approved by a unanimous vote.

Commissioner Cline proceeded to the consideration of approval of the Code of Ethics. Ms. Arricale asked Commissioner Cline and the Members of the Management Committee if it would

be preferred that she take the comments received during the Public Hearing, and create another draft of the Code of Ethics. Ms. Arricale noted that the draft would be circulated in time to be considered during the March meeting of the Management Committee and Commission in Orlando. Commissioner Cline agreed that, due to the nature of the comments received, that would be ideal.

Commissioner Cline proceeded to the next item on the Agenda, an Operational Update. Ms. Arricale provided the update. Ms. Arricale highlighted the upcoming meetings and their potential time frames. Ms. Arricale also noted that the IIPRC has entered into contractual services with Alice Fontaine, of Fontaine Consulting, LLC in Texas. Ms. Arricale explained that Ms. Fontaine would be responsible for the actuarial portion of the IIPRC review process.

Commissioner Cline asked if there were any other matters to be considered during the teleconference. Mr. Hoelscher provided a Report and Recommendation of the Product Standards Committee. Mr. Hoelscher reported that the Product Standards Committee would like to recommend that the Management Committee initiate the 60-day public comment period for the Individual Immediate Non-Variable Annuity Contract Standards. In his report, Mr. Hoelscher noted that these Annuity Standards are the fourth and final “core” annuity standards. Commissioner Cline asked if there was a motion to adopt the report and initiate the rulemaking process. Mr. Doane of Pennsylvania made the motion and Ms. Wallace of Michigan seconded the motion. Commissioner Cline asked Ms. Arricale to take a roll call vote. The motion was approved by a unanimous vote. There was no other business.

Commissioner Cline asked if there was a motion to adjourn. Mr. Beatty made the motion and Director Hudson seconded the motion. The meeting was adjourned.
